Left on Delaware to the four corners. Right on Kenwood. Go about 1 1/4 miles to Rockefeller Rd. The Health Care Center will be on your left: the building with the white portico.

Teresain House: 200 Washington Ave. Ext. Albany: Right on Delaware, right on Cherry Ave. extension, Continue on 85 through 3 traffic circles, follow to 90 West, 90 West to Fuller Rd., exit left onto Fuller Rd., right onto Washington Ave. Ext. Left at Rapp Rd. light, then quick right (follow sign) Teresian House on left side.

Delmar Reformed Church: 386 Delaware Ave., Delmar: Left on Delaware Ave., Right on Adams St., immediate Left into church parking lot.
